Accordingly, following services of Higher Education Department shall be covered under self attestation mode with effect from the date of issue of this notification .

2. The persons seeking service as mentioned above may submit their applications along with self attested documents.

3. While submitting documents in self attestation mode, the applicants shall also give an undertaking in the Self Declaration Form(as shown below). The applicant shall clearly mention his/her name in full along with signature and dates while self attesting the documents. The list of documents which are self attested shall be clearly mentioned in Self Declaration Form.

4. It may be noted that in case it is established that any applicant gives false declaration or gives false information in the declaration or tampers with the information in the document which is self attested, he / she shall be liable for action as per law. Further, if information furnished under self attestation is proved to be false, the benefit accrued or service derived, on strength of such declaration, shall be summarily cancelled or withdrawn/ forfeited as the case may be.


